## Consultation on modernising the repair and maintenance of fixed equipment and end-of-tenancy compensation in relation to Agricultural Tenancies in England

key organisations that represent the interests of agricultural landlords and tenants and the proposals included in the consultation reflect the feedback received.

- 7. Every response will be read and considered by the Agricultural Tenancy policy team in Defra.
- 8. We intend to publish a summary of responses to this consultation. Inevitably it will not be practical to describe every response in detail.

#### Confidentiality

- 9. When we publish the summary of responses to the consultation it will not include your personal name (unless you have asked us to include it) and other personal data such as contact details. The summary may contain the name of your organisation, if you are responding on an organisation's behalf.
- 10. Defra will retain copies of responses for a suitable length of time. Please note that a member of the public can ask to see copies of information held. If you need to keep any part of your response confidential, please tell us when you respond. Please note that confidentiality disclaimers automatically added to e-mails do **not** count.
- 11. Important: we will take your reasons into account if someone asks for information. Because we must comply with the law, including Freedom of Information legislation, we cannot promise that we will always be able to keep your details that you provide to us confidential.
