The expansion of the firewood market in recent years has driven a renaissance in woodland management and the suite of public benefits that a well managed woodland delivers. Yet still only 12% of the total amount of hardwood growth in England's woodlands is harvested. Forestry Commission research shows a strong correlation between the location of privately owned woodland and rural deprivation. By supporting not further regulating the firewood industry government can support fragile communities with few other sources of employment.
