# Pet travel: changes to the EU scheme

Defra, Scottish Government and the Welsh Government would like to invite your views on our proposed approach to the implementation of a new EU pet travel Regulation.

#### **Background**

A new EU pet travel Regulation (576/2013) was published in June 2013 and is due to come into effect on 29 December 2014, repealing and replacing the current Regulation (998/2003). Whilst the fundamentals of the regime will remain the same, a number of changes have been introduced which aim to strengthen compliance regimes, create greater consistency across the EU and improve the security and traceability of the pet passport.

## The consultation period

We have used informal discussions with a range of stakeholders to refine our implementation approach. In light of this previous engagement and as the fundamentals of the pet travel scheme will remain the same, a shorter consultation





period has been set, which will also enable us to meet the tight deadline for implementation of the EU legislation. This consultation will therefore run for 6 weeks and should be of interest to pet owners, veterinary practices, transport companies and anyone involved in pet travel.
