Consultation on the initial findings of the Review of the Welfare of Racing Greyhounds Regulations 2010

Dear Consultee

I am writing to invite views on the initial findings of the review of the Welfare of Racing Greyhounds Regulations 2010.

The Welfare of Racing Greyhounds Regulations came into force on 6 April 2010 and have been in force now for five years. The Government, in line with its commitment to review all new regulations after they have been in force for a period of time, is committed to undertaking a review of their effectiveness.

The aims of the Regulations, when introduced, were to ensure that all greyhound tracks in England are covered by the same minimum welfare standards and there will be improved traceability of greyhounds. Defra wishes to review the Regulations to establish whether, and to what extent, the Regulations have achieved their original objectives. Also, whether the objectives and scope of the Regulations are still valid, and whether regulation is still the best option for achieving those objectives. This review is not reviewing whether greyhound racing should be banned.

To help focus this consultation, Defra has undertaken and commissioned research to gather evidence on the effectiveness of the Regulations and their impact on greyhound welfare. Evidence was collected, in the form of the experiences of relevant stakeholders from across the industry, from track operators and track vets, to re-homing organisations and welfare groups. The report of the research – 'Exploring Effectiveness of Racing Greyhounds Legislation (2010)' is the main reference document for this consultation and represents the initial findings of the review of the Regulations.

This consultation seeks views on the initial findings of the review as set out in the report. Based on these findings and preliminary discussions with the GBGB, the consultation also sets out possible practicable options for further action to address the issues raised. This consultation stage is an opportunity for anyone to comment on the findings, options and submit any further evidence.

This will be an 8 week consultation period. It builds on the extensive engagement already undertaken in collecting the evidence for the initial findings of the review. This included interviewing, by telephone, some 44 people with experience of the operation of the Regulations and undertaking an on-line survey, to which some 103 people responded, of other stakeholders likely to have experience of the Regulations.
