Consultation on Proposed Amendments to the Veterinary Surgeons Act 1966 (VSA)

I am writing to invite your views on our proposals to amend the constitution of the Council of the Royal College of Veterinary Surgeons (RCVS), the statutory regulator of the veterinary profession.

This consultation will look at the current constitution (size & membership) of the RCVS governing body, the RCVS Council, to see if it can be modified to operate more efficiently and in the better interests of the public and the veterinary profession. The consultation sets out a number of possible options for change.

The current constitution and governance arrangements for the Council are laid down prescriptively in primary legislation. The relevant legislation is Section 1 of and Schedule 1 to the Veterinary Surgeons Act 1966. Because the VSA is primary legislation, any proposed changes can only be made through a Bill, or a Legislative Reform Order under the Legislative and Regulatory Reform Act 2006. As these are minor changes, it has been agreed that the best legislative vehicle to achieve these changes is a Legislative Reform Order (LRO).
