## Introduction

#### **Evaluation of proposals**

From 2019, producer compliance schemes (PCSs) must join the government's approved PCS Balancing System (PBS). This is intended to ensure that the costs of collecting and treating waste electrical and electronic equipment (WEEE) when requested by local authorities are shared amongst all PCSs with household WEEE obligations.

This consultation contains two proposals from external organisations for a PBS and administrator. Comments are invited on the extent to which each of the proposals meet the published evaluation criteria, available at:

This consultation will be of interest to producers of electrical and electronic equipment, approved producer compliance schemes, WEEE treatment facilities, waste management companies, electrical re-use organisations and local authorities.

This consultation will close on Monday 15 April 2019.

#### **Question 1**

Please score each of the two proposals received on how well they meet the published evaluation criteria as follows:

**0 - Unacceptable** - Nil or inadequate response. Fails to demonstrate an ability to meet the requirement.

**1 - Poor** - Response is partially relevant and poor. The response addresses some elements of the requirement but contains insufficient/limited detail or explanation to demonstrate how the requirement will be fulfilled.

**2 - Acceptable** - Response is relevant and acceptable. The response demonstrates a broad understanding of the requirement but may lack details on how the requirement will be fulfilled in certain areas.

**3 - Good** - Response is relevant and good. The response demonstrates a good understanding of the requirement and provides sufficient details on how the requirement will be fulfilled

**4 - Excellent** - Response is relevant and excellent overall. The response is comprehensive, unambiguous and demonstrates a thorough understanding of the requirement and provides details of how the requirement will be met in full.
