## **Consultation on draft Noise Action Plans**

1. I am writing to invite your views on three draft Noise Action Plans which have been published today, covering agglomerations (urban areas), roads and railways. This consultation forms part of the process of fulfilling our obligations under the Environmental Noise Directive (END) 2002/49/EC, which was transposed into English law by the Environmental Noise (England) Regulations 2006, as amended.

2. The END and the Regulations require us to produce noise action plans based on the results of strategic noise mapping, the third round of which was completed in 2017 by the Environment Agency on behalf of Defra.
