Consultation on due diligence on forest risk commodities

- 1. I am writing to invite your views on introducing legislation that is designed to prevent forests and other important natural areas from being illegally converted in to agricultural land. Our proposal would make it illegal for larger businesses to use forest risk commodities that have not been produced in accordance with relevant local laws, and they would need to undertake due diligence to show that they have taken proportionate action to ensure this is the case.

Consultation criteria

- 7. This consultation is in line with the Consultations Principles. This can be found at http://www.cabinetoffice.gov.uk/resource-library/consultation-principles-guidance
- 8. This consultation will last for 6 weeks. It draws on the extensive engagement conducted by an independent taskforce called the Global Resource Initiative (GRI), which the Government established in 2019 as part of our 25 Year Environment Plan to consider actions the UK could take to make international supply chains greener. The GRI drew on a wide range of expertise from across business, finance and civil society and consulted over 200 organisations to formulate their final recommendations report, which was published in March this year. One of their key recommendations was to introduce due diligence obligation on businesses, which this consultation responds to. The Government also regularly engages with businesses in the UK on their supply chains through the UK Roundtable on Sourcing Sustainable Palm Oil, established in 2012, and the UK Roundtable on Sustainable Soya, established in 2018.

Confidentiality and data protection

If you want the information that you provide to be treated as confidential, please be aware that, as a public authority, the Department is bound by the Freedom of Information Act and may therefore be obliged to disclose all or some of the information you provide. In view of this it would be helpful if you could explain to us why you regard the information you have provided as confidential. If we receive a request for disclosure of the information, we will take full account of your explanation, but we cannot give an assurance that confidentiality can be maintained in all circumstances. An automatic confidentiality disclaimer generated by your IT system will not, of itself, be regarded as binding on the Department.
