Consultation on the Plant Biosecurity Strategy for Great Britain and Additional Biosecurity Measures for High-Risk Tree Species.

- 1. As the Head of the UK Plant Health Service, and on behalf of Defra, the governments of Scotland and Wales, our agencies and delivery partners, I am writing to invite you to participate in the consultation on a refreshed Plant Biosecurity Strategy for Great Britain. We are seeking your views on the next steps we should collectively take to improve our plant biosecurity regime for Great Britain. The consultation is aimed at a wide range of audiences including the general public, and those working in the plant sectors. We are seeking views on the range of biosecurity initiatives, and approaches, as well as seeking information about people's general biosecurity behaviour. Your response will help inform our biosecurity approach over the next five years and inform the joint commitments we take forward with our stakeholders in the new strategy, which will be published in 2022.
- 2. We are also writing to invite your views on additional biosecurity measures associated with specific risks from trees. Your response will help inform policy thinking around preborder, at the border and inland biosecurity measures for high-risk trees. We will ask respondents about their views on the range of biosecurity measures currently in place and whether measures could be introduced in the future to strengthen our biosecurity regime
