Survey for the Joint Post-Implementation Review (PIR) of the Conservation of F and Species regulations 2017 and the Conservation of Offshore Marine Habitat Species regulations 2017

Overview

This survey aims to gather the views of stakeholders and users of the 'Conservation of Habitats and Species Regulations 2017 as amended' and the 'Conservation of Offshore Marine Habitats and Species Regulations 2017 as amended' (hereby termed the onshore and offshore Habitats Regulations respectively). The evidence gathered will inform the post-implementation review of these regulations (linked on the next page of this survey) and may also support any future wider policy work regarding improvements to the onshore and offshore Habitats Regulations.

We expect this review to be of interest to regulators, environmental NGOs, and industry groups, as well as others who have an interest in the regulations and how protected sites and species are regulated in the UK.

Scope of this survey

As part of Defra's statutory obligation to regularly review its regulations, we are conducting a joint post-implementation review of the onshore and offshore Habitats Regulations. This is being conducted under Regulation 142 in the onshore regulations and Regulation 82 in the offshore regulations.

Broadly, the onshore and offshore Habitats Regulations set out rules for designating, protecting and managing sites that are important for a defined list of habitats and species requiring strict protection. A more extensive summary is included below.

This survey seeks to gain stakeholder views to inform the post-implementation review, by collecting views and evidence regarding the effectiveness of the implementation, any unintended consequences of the onshore and offshore Habitats Regulations, and suggestions for possible refinements to the entirety of the onshore and offshore Habitats Regulations.

<u>Views expressed in this survey should focus on the time period from 2017 to present, however evidence relating to implementation of the onshore and offshore Habitats Regulations before 2017 can be included where relevant.</u> The review of the onshore regulations (which includes adjacent territorial seas up to 12 nautical miles) covers England only. The offshore regulations and therefore the offshore review covers the whole of the UK offshore marine area. There will be opportunity in this survey to indicate whether you are answering in relation to the onshore regulations, offshore regulations, or both.

The purpose of this post-implementation review of the onshore and offshore Habitats Regulations is to provide evidence to assess:

the extent to which the regulations' objectives have been achieved and whether they remain appropriate,

the effectiveness of the regulations' implementation to date,

and whether the objectives could be achieved with less regulation.

As well as capturing the views and experiences of a wide range of interested stakeholders via this survey, this review will also analyse the extensive existing evidence base surrounding implementation of the onshore and offshore Habitats Regulations. Therefore, when answering this survey, <u>please refer to existing evidence sources and previous consultation or survey responses where possible, including reports and reviews already published or held by your organisation.</u> The last question allows you to upload documents for this purpose.

Please note that views expressed in this survey may also be used in wider relevant policy development, including longer-term improvements to implementation of the onshore and offshore Habitats Regulations.

We are aware that respondents might also be feeding into related engagement surveys, and we are coordinating with these areas to share relevant findings. Therefore when answering this survey, if an answer that you have previously submitted to a recent Defra stakeholder engagement activity is relevant (for example Defra's recent Habitats Regulations Assessment (HRA) Guidance survey which closed 22nd March 2024), you are welcome to refer to this in your answer by writing 'see x's response to x engagement survey', and we will follow up accordingly.

Scope of the onshore and offshore Habitats Regulations

Summary of key aspects of the onshore Habitats Regulations 2017:

The Conservation of Habitats and Species Regulations 2017 consolidate the Conservation of Habitats and Species Regulations 2010 and subsequent amending instruments. These regulations are assimilated from the EU Habitats and Wild Birds Directives, and must secure compliance with the requirements of the Directives (as per Regulation 9 in the onshore regulations). Note that the onshore and offshore Habitats Regulations were amended in 2019 to ensure their functionality when the UK left the EU, with no change to policy (see the Conservation of Habitats and Species (Amendment) (EU Exit) Regulations 2019 No.579).

Part 1 requires public bodies to exercise their nature conservation functions to comply with the Habitats Directive and the new Wild Birds Directive, as well as imposing duties on public bodies in relation to wild bird habitats and requires nature conservation bodies to review and report on whether the obligations have been met.

Part 2 makes provision for the selection, designation or classification, registration and notification of sites to be protected under the Habitats Directive. Part 2 also makes provision in respect of European sites for control of damaging operations, special nature conservation orders and restoration orders, byelaws and compulsory purchase.

Part 3 provides for the protection of certain wild animals and plants, making it an offence, subject to exceptions, deliberately to capture, kill or disturb those animals or to trade in them, as well as prohibiting the use of certain methods of capturing or killing wild animals. Part 3 also makes it an offence, with exceptions, to deliberately pick, collect, cut, destroy or trade in certain plants.

Part 4 imposes a duty on the Secretary of State and Welsh Ministers to make arrangements for the surveillance of the conservation status of natural habitats and species protected under the Habitats Directive and requires them to make arrangements to establish a system to monitor the incidental capture and killing of certain animals. Part 4 also makes it an offence deliberately to introduce from a ship into the sea new species that are not native to Great Britain.

Part 5 provides for the licensing of certain activities relating to animals and plants, including making it an offence to make false representation in order to obtain a licence and failing to comply with a licence condition.

Part 6 requires the effect on a European site to be considered before the granting of consents or authorisations of a kind specified in regulations 70 to 104.

Part 7 sets out enforcement powers including powers of entry, search and taking of samples.

Part 8 contains provisions relating to the advisory roles of named Arm's Length Bodies in England and Wales, as well as containing amendments and revocations consequential on the consolidation.

Summary of key aspects of the offshore Habitats Regulations 2017:

The Conservation of Offshore Marine Habitats and Species Regulations 2017 consolidate the Offshore Marine Conservation (Natural Habitats, &c.) Regulations 2007, and make minor modifications reflecting changes to related legislation. The Regulations make provision in relation to the offshore marine area, offshore marine installations and certain ships and aircraft. These regulations are assimilated from the EU Habitats and Wild Birds Directives, and must secure compliance with the requirements of the Directives (as per Regulation 6 in the offshore regulations).

Part 1 identifies the competent authorities for the purposes of these Regulations and imposes a duty on competent authorities exercising functions relevant to marine conservation to do so in such a way as to secure compliance with the requirements of the Directives.

Part 2 makes provision for the conservation of natural habitats and habitats of species.

Part 3 creates offences for the protection of wild birds, animals and plants, which in some instances are subject to defences.

Part 4 requires the Secretary of State to make arrangements for surveillance and monitoring of species and habitats in the offshore marine area and to take further action for the protection of species, in the light of that surveillance or monitoring. In certain cases the Scottish Ministers, the Welsh Ministers and Northern Ireland departments must also take measures to protect species. Part 4 also makes it an offence deliberately to introduce a non-native animal or plant.

Part 5 makes provision for the licensing of activities which would otherwise be offences under Part 3 and regulation 54.

Part 6 sets out enforcement powers including powers of search and entry, search and evidence gathering.

Part 7 deals with matters such as education, research and reporting to the European Commission on the implementation of the Habitats Directive.

The onshore and offshore Habitats Regulations lay down rules for the protection and management of habitats and the protection and exploitation of species. The regulations are assimilated from the EU Council Directive 92/43/EEC on the conservation of natural habitats and of wild fauna and flora (the 'Habitats Directive') and elements of the EU Council Directive 2009/147/EC on the conservation of wild birds (the 'Wild Birds Directive'). There is a duty within the regulations to secure compliance with the requirements of the Habitats and Wild Birds Directives (see regulation 9 in the onshore regulations).

The objectives of the Habitats and Wild Birds Directive, which the onshore and offshore regulations must comply with, are below:

The objective of the Habitats Directive is to maintain or restore, at favourable conservation status, natural habitats and species of wild fauna and flora of Community interest (see Article 2.2 of the Habitats Directive, linked in page 1 of this survey). The objective of the Wild Birds Directive is to preserve, maintain or re-establish a sufficient diversity and area of habitats for all species of naturally occurring birds in the wild state in the European territory of the Member States to which the Treaty applies (see Article 3.1 of the Wild Birds Directive, linked in page 1 of this survey).

The onshore and offshore Habitats Regulations ensure that the UK meets its international commitments including under The Convention on the Conservation of European Wildlife and Natural Habitats (the Bern Convention) and The Convention on the Conservation of Migratory Species of Wild Animals (the Bonn Convention).
