# Consultation on sites proposed for designation as Highly Protected Marine Areas (HPMAs).

The Department for Environment, Food and Rural Affairs (Defra) invites your views on the proposal to designate a number of sites as pilot Highly Protected Marine Areas (HPMAs) in English waters. This consultation is being carried out by Defra and will be open from 6 July 2022 to 28 September 2022.

We want to continue protecting and improving the health of the marine environment and also support sustainable use. Protecting our oceans can have a positive impact on climate change resilience and can address biodiversity loss which will deliver benefits for society and human health.

The purpose of HPMAs is the protection and recovery of marine biodiversity. HPMAs will take a 'whole site approach', conserving all species and habitats within the HPMA boundary. By setting aside some areas of sea with high levels of protection, HPMAs will allow nature to recover to a more natural state. This will contribute to the government's vision for 'clean, healthy, safe, productive and biologically diverse ocean and seas.'

We are consulting on five candidate HPMAs and propose to designate a number of these as pilot HPMAs within a year of this consultation. We will use powers in the Marine and Coastal Access Act 2009 to designate the HPMAs as marine conservation zones. The candidate HPMAs overlap with existing marine protected areas and will complement the existing marine protected area network in English waters.

To achieve high levels of protection some activities will need to be restricted in HPMAs. However, HPMAs are not no-go zones and many activities, especially recreational ones happening at non-damaging levels, will still be able to occur. This consultation will seek to understand the impacts of HPMAs on you, your business and the environment.
