Consultation on discards reform

The Department for Environment, Food and Rural Affairs (Defra) invites your views on the consultation which launches our vision for reforming the management of discards in England.

This is a 12 week consultation running from 17 July to 9 October 2023.

The consultation includes the key principle of counting all fish catches against quota, initially through options for better catch accounting, but also through more tailored, fishery focussed approaches.

It also proposes that steering groups are set up with industry and other stakeholders to develop measures to avoid and reduce unwanted catch. This could include the use of more selective fishing gears.

This consultation will be of interest to fishing industry stakeholders in England. The proposals are also likely to be of interest to retailers and other stakeholders in the seafood supply chain, consumers, NGOs (non-governmental organisations), gear manufacturers and fishing technology companies.

This consultation is an opportunity for you to help shape and influence the future of discards management policy in England. We welcome your views and comments on the proposals.

It should be read alongside the parallel consultations on expanding the use of remote electronic monitoring in English waters, and the first draft fisheries management plans.
