Natural England has now decided how to proceed following its review of the above long-term directions to restrict CROW Access rights on this land. The two directions above are being reviewed together due to their proximity and similarity of issues. A consultation was held between 22 November and 16 December 2024 with statutory consultees and the general public; we did not receive any comments.

Outcome of the reviews

Natural England's decision is to leave the original directions unchanged in the way they were originally proposed and extend the end dates for a further six years. As these directions are a continuation of the current situation with only the end dates being changed a second consultation is not required.

Background to the sites and existing directions

The caravan parks listed above are situated on the Norfolk coast on the route of the King Charles II England Coast Path. The route at Beeston Regis Holiday Park and Laburnum Caravan Park also coincides with the Peddars Way and Norfolk Coast Path running through the sites.

All the parks have an established policy of restricting accompanied dogs to leads while on site. With the introduction of new coastal access rights on 11 December 2014, directions were given to restrict dogs to leads on the Coast Path all year round on each of these sites, to replicate this management.

The four parks are closed for some of the year, with a varied period of closure between sites ranging from 6 weeks to about 4 months (the closure period can vary each year). The managers on the sites were concerned about the introduction of new coastal access rights and asked for the restriction to be made year-round to give a consistent message to access users. When deciding the period of the restriction, Natural England looked to strike a balance between the interests of the public in having a right of access and the interests of the businesses. To provide clarity for walkers Natural England decided it was reasonable to apply a year-round exclusion on all the sites,

Natural England gave the original long-term directions on 26 November 2014. These directions were reviewed in 2019 and were extended for a further 6 years on 3 December 2019.

As part of the 2024 review, we received confirmation from each of the parks that the dog policy remains unchanged, and that they wish the restriction to continue.

The National Trail Officer will review the signage at these sites, to ensure dog walkers are clear on where they are entering and exiting a restricted area and must keep dogs on a lead.

Where a direction restricts access indefinitely, for more than five years, for part of every year, or for part of at least six consecutive years, we have a statutory duty to review it within five years of the date of its issue.
