What personal data is collected and how it is used

Answers to all questions are optional. All personal data is used solely for the processing of your consultation response and communicating the findings of the consultation to you. The information collected will be stored for the length of the project, for a minimum of 5 years. Any information you give in response to the Diversity Monitoring questions will be separated from your consultation response and will not be associated with you, or your responses.

Your responses will help to inform Natural England's decision on whether to take forward our proposals and, if so, where the boundaries should be.
