Subject of letter

I am writing to invite views on **Best practice guidance for developing compensatory** measures in relation to Marine Protected Areas.

The government has developed this guidance as a framework to assist:

- regulatory bodies responsible for decision-making in the marine area,
- statutory nature conservation bodies (SNCBs) who provide advice to public authorities and developers, and
- any other public authorities whose functions are capable of affecting MCZs, SACs or SPAs to,

consider how to reduce and mitigate impacts on the marine environment within MPAs and, where this isn't possible how to deliver compensatory measures.

This consultation seeks views from all interested parties on the proposed guidance. We are particularly keen to hear from marine industries that are subject to the consenting and / or licensing process on how applicable and feasible the guidance is.
