Background

The policy area of Plant Varieties and Seeds (PVS) covers Plant Variety Rights (intellectual property rights of plant breeders), plant variety registration (national listing), setting standards for marketing and certification of seed and other plant propagating material and ensuring that these standards are upheld.

Defra, Scottish Government, Welsh Government and DAERA are working together to develop a UK PVS Strategy spanning five years. This will be the first strategy in the PVS area and developing it will be an opportunity to engage with industry and other stakeholders to set out a shared vision, priorities, and actions to achieve these.

We intend the strategy to be a means of setting direction and providing an overall framework to support prioritisation and provide clarity.

Inviting your views

We are keen to invite ideas from across industry at an early stage to feed into our strategy. This call for ideas seeks to gather initial input and we plan to continue engagement throughout the process.

This document outlines a proposed vision for the PVS policy area and the outcomes we would like to see. We welcome your views on these as well as on ideas for actions that can help achieve them. The call for ideas will be open from 26th September until 19th December. The feedback gathered from this call for ideas will be used to draft the first Plant Varieties and Seeds strategy. Stakeholder engagement will continue throughout the strategy development process and a consultation will be conducted when an initial draft is ready.
