## UK Call for Comments on the POPRC Evaluation Documents 2023

I am writing to invite comments on three documents currently being reviewed by the POPs Review Committee (POPRC) of the Stockholm Convention, ahead of its meeting in October 2023. The documents are the Risk Management Evaluations (RMEs) of two substances: MCCPs (proposed by the UK) and a PFAS substance called LC-PFCAs; and the Risk Profile of a substance called chlorpyrifos.

The POPRC meets every year, the next meeting is early October 2023. Between meetings there is a period of information gathering and rounds of commenting on the draft documents. Previously, in October 2022 we requested information to aid the drafting of the documents evaluated by the POPRC. This call for comments invites the public to provide comments on the second drafts of these documents.

Responses to this call for comments will be used to inform the UK's submission to the secretariat of the Stockholm Convention. Submissions to the Convention are published on the Convention's website.
