# Consultation on a set of specific proposed changes to official statistics produced by the Defra group

The Defra group (the core department, together with our agencies and arm's length bodies) produces and uses a wide range of official statistics. They are used internally to inform policy making and operational delivery and are shared externally, so that others can use the information.

We are inviting your views on a proposed set of specific changes to 'Official Statistics' produced across the Defra group in line with our aim of being an open, efficient and data driven department.

We are also inviting any general feedback on the uses made of our statistical products; other ideas on how we can further reduce burdens on survey respondents or introduce further efficiencies in our compilation of statistics.

While the consultation primarily focuses on the specific proposals, as context all of the statistical activities of the Defra group are listed in the annexes to this document.

There is a requirement to consult users on the proposals under the UK Statistics Authority's Code of Practice for Official Statistics (under which all official government statistics are compiled).
