# Consultation on the Marine Strategy Part 1: UK Updated Assessment and Good Environmental Status

Updated assessment of progress towards achieving Good Environmental Status (GES) and proposals for new objectives, targets and indicators for the next 6 years

Defra, the Department of Agriculture, Environment and Rural Affairs Northern Ireland, the Scottish Government and the Welsh Government are seeking views on the third update to the UK Marine Strategy Part One, as required under the UK Marine Strategy Regulations 2010.

This update forms part of the UK's ongoing commitment to restoring and protecting the marine environment while supporting sustainable economic growth through a thriving ocean economy. It sets out our assessment of progress made towards achieving the targets set for GES in the Marine Strategy Part One in 2019. It also sets out proposals for updated high level objectives, targets and indicators to be used for the next reporting cycle. Where possible we have based our assessments on those completed for the OSPAR Convention for the Protection of the North East Atlantic Quality Status Report (QSR2023).

This consultation seeks views on:

- The updated assessment of the state of the UK's seas and progress made since the 2019 update.
- The proposed determination of GES for the next 6-year assessment cycle (referred to as 'overarching targets' for GES); and
- The criteria, environmental targets and indicators proposed for monitoring progress during the next cycle.

This consultation relates solely to the updated UK Marine Strategy Part One. It does not include the UK's marine monitoring programme outlined in Part Two, nor the programme of measures detailed in Part Three of the Marine Strategy.
