6. Responses should be received by 20 November 2023.

The consultation period is less than 12 weeks. This shortened consultation period is necessary to ensure that local authorities, waste collectors and non-household municipal



premises receive the policy decisions in sufficient time to implement the changes by the required dates.

To reduce the impact of this shortened consultation period, we will hold stakeholder events alongside the consultation. Additionally, prior to this consultation we have:

- Held two previous consultations on the changes to policy on the separate collection of waste in England, in 2019 and 2021. The 2021 consultation included questions on the statutory guidance, which have informed this consultation.
- Worked closely with WRAP and the Environment Agency to draft the consultation, including the draft statutory guidance text.
