Introduction

This document sets out the consultation questions in our draft Waste Prevention Programme for England. Please use this document if you would like to respond by way of a hard copy. Our preference is for consultation responses to be provided online through Citizen Space. If so, this document will help you understand how your answers will be used and explains issues around data protection and confidentiality.

What are we proposing to do?

We are consulting on a new Waste Prevention Programme for England that sets out priorities for action to manage our resources and waste in accordance with the waste hierarchy - which means preventing waste and increasing reuse, repair and remanufacture of products.

Why do we need to do this?

To take forward the strategic direction set by

"Our waste, our resources: a strategy for England". This states how we will better manage our material resources: how we will promote resource efficiency, move towards a circular economy, and minimise the residual waste produced.

We will seek to build on this through the revised Waste Prevention Programme focusing on the top of the waste hierarchy, which means increasing reuse, repair and remanufacture, as well as use of industrial by-products. Our goal is to develop the key cross-cutting and sector-specific aspects of the Strategy. The aim is to embed our circular economy approach and retain products and goods in circulation for as long as possible and at their highest value.

We are required by the Waste (England and Wales) Regulations 2011 to have a Waste Prevention Programme ('Programme') for England and to review it, and revise it as required. Following the publication of the review of the last Programme we are now publishing a new draft Programme for comment.

Who will be affected by the proposals?

The Waste Prevention Programme will have a bearing on industry, retail, the waste management sector amongst others, and is of relevance to households and the third sector also.

Why are we consulting?

In order to sound out those with an interest in waste prevention on our proposals. There is a legal duty to consult on the draft Programme and to give consultees an opportunity to comment on the proposals. We are giving respondents an opportunity to comment on: our approach to waste prevention, whether we have identified the appropriate priority areas for action, and on the measures the government proposes to take. The Devolved Administrations are responsible for producing their own Waste Prevention Programmes which together with this draft Programme will cover the whole of the UK.

Confidentiality and data protection

The reason for this is that information in responses to this consultation may be subject to release to the public or other parties in accordance with the access to information law (these are primarily the Environmental Information Regulations 2004 (EIRs), the Freedom of Information Act 2000 (FOIA) and the Data Protection Act 2018 (DPA)). We have obligations, mainly under the EIRs, FOIA and DPA, to disclose information to particular recipients or to the public in certain circumstances. In view of this, your explanation of your reasons for requesting confidentiality for all or part of your response would help us balance these obligations for disclosure against any obligation of confidentiality. If we receive a request for the information that you have provided in your response to this consultation, we will take full account of your reasons for requesting confidentiality of your response, but we cannot guarantee that confidentiality can be maintained in all circumstances.
 - c. If you click on 'No' in response to the question asking if you would like anything in your response to be kept confidential, we will be able to release the content of your response to the public, but we won't make your personal name and private contact details publicly available.

- d. There may be occasions when Defra will share the information you provide in response to the consultation, including any personal data with external analysts. This is for the purposes of consultation response analysis and provision of a report of the summary of responses only.
